**RULES OF THE TRACK**

- The driver must be 152cm (5ft) tall and a minimum of 12 years of age to drive on the Kart Experience Track.
- You must participate in the safety and operation briefing prior to entry to the track.
- Helmets and head socks must be worn by all drivers.
- Helmet visors must be worn down.
- Enclosed footwear must be worn.
- All loose clothing such as scarves, key chains etc. must be removed.
- A 'no contact' rule is in place – Dangerous drivers will be disqualified and removed from the circuit.
- You must slow down to a walking pace when returning to the pit area.
- DO NOT TOUCH or try to adjust the engine at any time.
